Details of the charge against you

1. What is the charge?

You did with intent to attempt to pervert the course of justice in respect of the judicial power of the Commonwealth second a motion in the Senate on the 7th November 2016, to refer the question of the possibility that Rodney Norman Culleton was subjected to a term of imprisonment by a Magistrate at Armidale, and the Senate did refer the said Rodney Norman Culleton eligibility to the said High Court, and you continued to allow the matter to continue, even after an agreed Statement of Facts was filed in that Court proving beyond any reasonable doubt that the said Rodney Norman Culleton was never under potential imprisonment and thereby in breach of your sworn public duty, attempted to pervert the course of justice in respect of the judicial power of the Commonwealth. An Offence against S 43 Crimes Act 1914 (Cth). Under S 129 (5) Evidence Act 1995, the transcript of proceedings in the Senate are admissible against you.
